ORDINANCE NO. 2001-001

REGULATE UPON THE WATERS OF BIG BEARSKIN LAKE
AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF

The Town Board of the Town of Cassian, Oneida County, Wisconsin, does ordain as follows:

WHEREAS, the Town of Cassian entered into a joint ordinance with the Town of Lake Tomahawk and the Town of Hazelhurst on July 4, 2001 with the intent to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with the public rights and interest and the capacity of the water resources of BIG BEARSKIN LAKE.

WHEREAS, while the Town of Lake Tomahawk and the Town of Hazelhurst has no restrictions attached to their ordinance, the Town of Cassian made the following restriction to both their ordinance and DNR application

"5 YEARS ONLY, MUST BE REAPPROVED AFTER 5 YEARS"


THEREFORE, be it hereby ordained by the Town Board of the Town of Cassian, Oneida County, Wisconsin, that the term of this ordinance be amended to not have any expiration date and will remain in effect until changed by the Cassian Town Board. All other parts of the original ordinance will remain in full effect.

This ordinance as amended shall be effective upon the publication or posting by the Town Clerk as required, pursuant to s.60.80, Wis. Stat.





A SOLE ORDINANCE TO REGULATE UPON-THE WATERS OF BIG BEARSKIN LAKE AND PRESCRIBING PENALTIES:FOR VIOLATION THEREOF:

The Town Board of the Town of Cassian do ordain as follows:

Section I Applicability and Enforcement

- (a) The provision of this Ordinance shall apply to the waters of Big Bearskin Lake.
- (b) This chapter shall be enforced by the officers of the Oneida County Water Safety Patrol.

Section II Intent

The intent of this ordinance is to provide safe and healthful conditions for the enjoyment of aquatic recreation consistent with the public rights and interest, and the capacity of the water resources

Section III. State Boating and Safety Laws Adopted

State boating laws as found in ss.30.50 to 30.71, Wisconsin Stats., are adopted by reference.

Section IV: Definitions

- (a) "Slow/No-Wake" means that speed at which a boat moves as slowly as possible while maintaining steering control:

Section V.

Controlled Area

No person shall operate a boat faster than slow-no-wake in the following waters of Big Bearskin Lake:

- (a) Waters of Mud Bay located in the Northwest portion of Big Bearskin Lake beginning at the mouth of the bay.
- (b) Waters of Kleeme Bay located directly South of Mud Bay in Big Bearskin Lake.
- (c) Waters of Outlet Bay located at the Southern end of Big Bearskin Lake beginning at the mouth of the Bay:

Section VI:

Posting Requirements

The Town of Cassian shall place and maintain a copy of this Section at all public access points within the jurisdiction of the Town:

Section VII. Penalties

Wisconsin state boating penalties as found in ss.30.80, Wisconsin Stats., and deposits as established in the Uniform Deposit and Bail Schedule established by the Wisconsin Judicial Conference, and hereby adopted by reference with all references to fines amended to forfeitures and all references to imprisonment deleted.

Section VIII. Severability

The provisions of this ordinance shall be deemed severable-and it is expressly declared that the Town Board would have passed the Other provisions of this ordinance irrespective of whether or not one or more provisions may be declared invalid: If any provision of this ordinance or the application to any person or circumstances is held invalid, the remainder of the ordinance and the application of such provisions to other persons or circumstances shall not be affected:

Section IX: Effective Date

This section will become effective upon passage and the day after publication
